AMENEDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF NORTH CREEK LANDING

(Beaufort County, North Carolina, Book 882, Page 49; Book 1043, Page 877 (supplemented); and Book 1714 Page 73 (amended))

RE: RESTRICTIONS ON USE AND OCCUPANCY

Pursuant to the requirements of the North Carolina General Statutes – North Carolina Planned Community Act, Chapter § 47F-2-117, Amendment of Declaration, “...the declaration may be amended only by affirmative vote of written agreement signed by lot owners of lots to which sixty-seven percent (67%) of the votes in the Association are allocated...” The Declaration of Covenants, Conditions and Restrictions of North Creek Landing dated June 12th 1987, Article 13 – Restrictions on Use Occupancy, Section F, is amended to read as follows:

“No trade, commerce or other activity which may be considered a nuisance to the neighborhood shall be carried upon any lot and no short term or vacation rentals shall be permitted. All rentals shall be 12 months in duration, to

maintain a single family residential neighborhood appeal. No trade materials or inventories may be stored upon any Lot and no trucks larger than one (1) ton, house trailer (other than camping trailers) or mobile home may be stored or regularly parked on any Lot. No sign or billboard of any kind shall be erected or allowed to remain on any Lot other than a "For Sale" or "For Rent" sign."

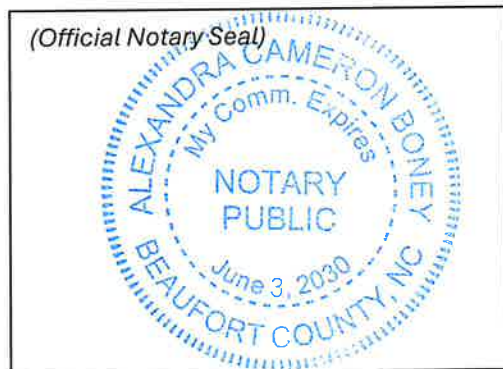
